Re: 2012 NOMINAL ROLL WORKSHOPS AND REPORTING SUBMISSION UPDATE

I am writing to inform you that the 2012 Nominal Roll call package is delayed and has resulted in our need to reschedule the Nominal Roll Workshops from September to October 2012. We regret any inconvenience this may have caused.

We are aware the First Nations Education Steering Committee (FNESC) has invoked the dispute resolution clause of the Tripartite Education Framework Agreement over concerns with changes in the reporting requirements in the 2012 Nominal Roll. The department is committed to working with FNESC to address these concerns. The outcome of our negotiations will not impact the need to explain the new Education Information System (EIS) through the rescheduled regional workshops.

We also recognize there is now an overlap with the FNESC regional session in Prince George Oct. 15 and 16. Therefore, additional nominal roll workshops have been added in Vancouver to help accommodate participation and travel expenses will be covered for one delegate per community to attend an alternate workshop.

The afternoon of each workshop includes a computer lab on the nominal roll and how to use the new Smart PDF report. The October training dates will ensure each participant has their organization's Nominal Roll Student and Staff Census Report DCI 462572 "rollover" document in Smart PDF at the workshop.

Due to the delay in delivery of the nominal roll call package, and the change in workshop dates, the submission date for the Nominal Roll Student and Staff Census Report DCI 462572 will be extended from October 15 to November 15, 2012.



If you have already registered for one of our nominal roll workshops, being co-facilitated with Naut'sa mawt Tribal Council (NmTC), Kirstin Sware at NmTC will be contacting you with new workshop dates and details and to confirm your registration.
