As indicated previously, this funding program requires that all students listed in the SEP Workplan must have an IEP in place by December 1, 2021.

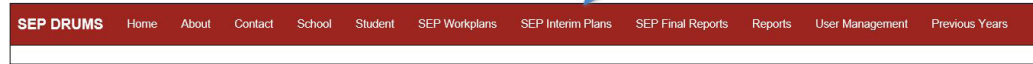

- IEPs for all students listed on the 2021-2022 workplan

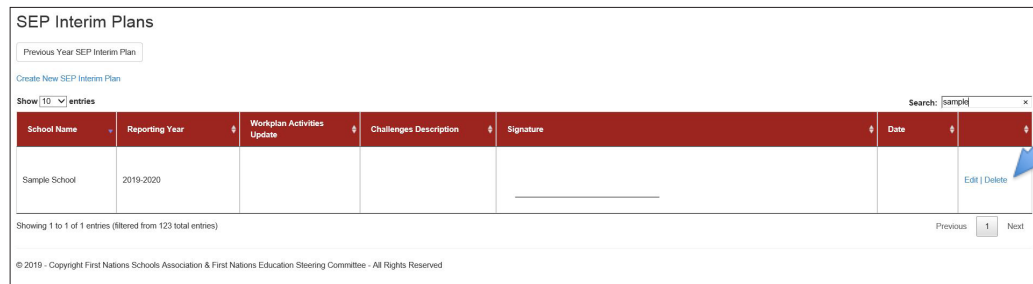

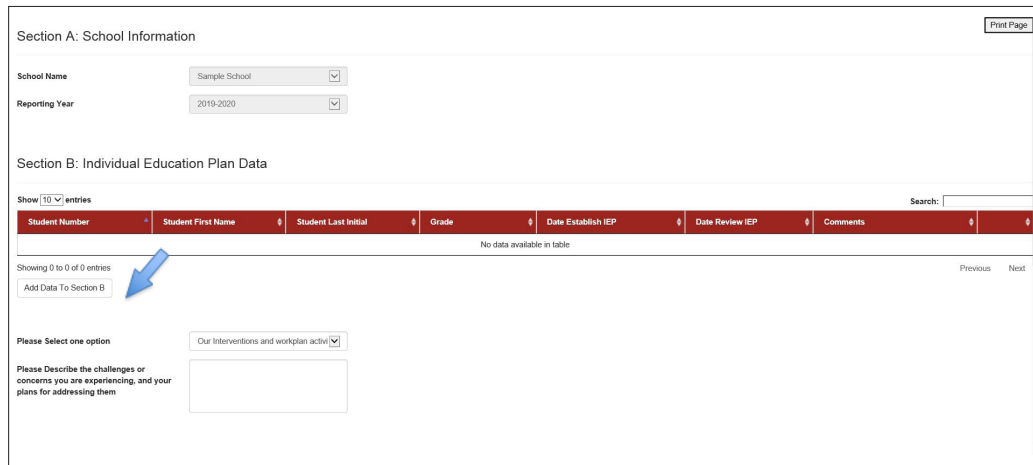
1. Log into SEP DRUMS (<https://sepdrums.fnesc.ca/Account/Login>)
